3. The High Desert Education Service District has developed and submitted on August 3rd, 2016 a Radon Testing Plan and Protocol to the Oregon Health Authority. Community members can access a copy of the radon plan here: www.hdesd.org. Test results will be made public and posted to the district website here: www.hdesd.org.

4. In compliance with OAR 581-022-2223(5)(d) the High Desert Education Service District has initiated a water testing protocol and plan which was implemented on August 12, 2016. The plan includes drawing samples from every accessible water location in all of the buildings listed. Samples were taken first thing in the morning prior to anyone in the buildings so the water had a chance to lay in the pipes for a minimum of 6 hours. Umpqua Research Company in Myrtle Creek, Oregon was the OHA accredited lab used for all testing.

In the event that a water source that isn't used, such as a hose bibb, fails the test we will flush the water line, let the water set in the line overnight and then retest. If the source continues to fail we will prevent access to that location and effect the necessary remediation.

Additionally, the High Desert Education Service District will test 5% of the sites in each building every five years. Subsequent test results will be posted on the district website.

5. In compliance with OAR 581-022-2223(5)(e) and the United States Environmental Protection Agency's Renovation, Repair and Painting Program Rule, the High Desert Education Service District will only contract with certified lead based paint renovation contractors licensed by the Oregon Construction Contractors Board.

6. In 2012, the High Desert Education Service District adopted the Integrated Pest Management Plan and the Facility Director since then has annually been certified as the IPM Coordinator.

7. The High Desert Education Service District will make all test results and detailed information explaining the test results available to the public within 10 business days of receiving the results.
